#### 1.1 PURPOSE.

Gray County is requesting statements of qualifications and experience from all interested qualified architects desiring to provide professional Architectural Services for the redesign of a newly purchased building at 300 W. Kingsmill, Pampa, Texas 79065.

## PROJECT DESCRIPTION

Gray County is seeking qualified architecture firm(s) to assist the County in developing architectural designs for the redesign of a newly purchased building at 300 W. Kingsmill, Pampa, Texas 79065. The facility was previously a banking facility. The County is requesting the redesign of one existing 2 story building with multiple offices and a large foyer in the building. The building will be redesigned to accommodate first floor county financial departments and second floor courtroom and Justice of the Peace offices. The selected architecture firm(s) will work with the County to determine a basis of design, draft design plans, assist in the bidding phase and perform administration of the construction phase.

#### 1.2 PROCEDURE.

Firms are encouraged to submit statements of qualifications and experience to be kept on file in the Gray County Judge's Office. For a given project, the Commissioner's Court will evaluate responses and select, in order of preference, a short list of at least three firms. Responses will be ranked on the basis of demonstrated experience, competence, and qualifications. Fees, price, work hours, or any other cost information will not be considered in the development of the short list.

Gray County will then enter into negotiations with the highest qualified firm. The negotiations will first establish the scope, terms and conditions, and time limits for the proposed contract. Once agreement is reached between Gray County and the selected firm, the County will request a fee proposal from the firm. If agreement is reached, the County will retain the firm and enter into a written contract with it. If an agreement cannot be negotiated with the selected firm, the County will then enter into negotiations with the next most qualified firm. This procedure will continue until agreement is reached and a contract is produced. If the County cannot negotiate an agreement, the procedure will be terminated.

## **1.3 EVALUATION PROCESS.**

While Gray County appreciates a brief, straightforward, and concise reply; Respondent must fully understand that the evaluation is based on the information provided. Accuracy and completeness are essential. Omissions, ambiguous, and equivocal statements may be construed against the respondent. The RFQ response may be incorporated into any contract which results from this RFQ, and vendor(s) are cautioned not to make claims or statements it is not prepared to commit to contractually. Failure of the vendor to meet such claims will result in a requirement that the vendor provide resources necessary to meet submitted claims.

# The Gray County Commissioner's Court may initiate discussions with selected vendors; however, discussions <u>MAY NOT</u> be initiated by vendors.

The Gray County Commissioners Court expects to conduct discussions with vendor's representatives authorized to contractually obligate the vendor with an offer. Vendors shall not contact any Gray County personnel during the RFQ process without the express permission from the Gray County Judge. The Gray County Judge will disqualify any vendor who has made site visits, contacted Gray County personnel, or distributed any literature without authorization from the Gray County Judge.

All correspondence relating to this RFQ, from advertisement to award shall be sent to the Gray County Judge's Office. All presentations and/or meetings between Gray County and the vendor relating to this RFQ shall be coordinated by the Gray County Judge's Office.

Selected vendors may be expected to make a presentation/product demonstration to the Gray County Commissioners Court. Proposals, vendor presentations, and product/service evaluations may develop into negotiating sessions with the vendor(s) as selected by the Gray County Commissioners Court. Gray County expects to conduct negotiations with vendor representatives authorized to contractually obligate the vendor with an offer. If vendor is unable to agree to contract terms and conditions, Gray County reserves the right to terminate contract negotiations with that vendor and initiate negotiations with another vendor. In addition to the presentation, visits by the Gray County Commissioners Court to representative vendor client sites may be conducted where the proposed solution can be demonstrated in a production environment.

# 1.4 ARCHITECTURE FIRM'S SERVICES.

A. A description of services that may be utilized under this RFQ includes:

- 1. Evaluate the County's architectural needs for a facility redesign.
- 2. Create a schematic design of the redesigned facility.
- 3. Provide bid phase services.
- 4. Provide construction administration services.

## 1.5 LAWS AND REGULATIONS.

A. The Architectural Firm(s) must comply with all laws, ordinances, and rules and regulations which govern the work specified in this contract.

## 1.6 INSURANCE.

The contractor (including any and all subcontractors as defined in **Section 1.7.1.3** below) shall, at all times during the term of this contract, maintain insurance coverages with not less than the type and requirements shown below. Such insurance is to be provided at the sole cost of the contractor. These requirements do not establish limits of the contractor's liability.

All policies of insurance shall waive all rights of subrogation against the County, its officers, employees and agents; a copy of the policy wording or endorsement is required.

Contractor shall furnish Gray County with Certificate of Insurance naming Gray County as additional insured and will provide the actual policy wording or endorsement showing as such.

All insurance must be written by an insurer licensed to conduct business in the State of Texas.

## 1.7 WORKER'S COMPENSATION INSURANCE.

## 1.7.1 Definitions:

1.7.1.1 **Certificate of coverage ("Certificate")** – A copy of a certificate of insurance, a certificate of authority to self-insure issued by the commission, or a coverage agreement, DWC-81, DWC-82, DWC-83, or DWC-84 showing statutory workers' compensation insurance coverage for the person's or entity's employees providing services on a project, for the duration of the project.

1.7.1.2 **Duration of the project** – Includes the time from the beginning of the work on the project until the contractor's/person's work on the project has been completed and accepted by the governmental entity.

1.7.1.3 **Persons providing services on the project ("subcontractor") in article 406.096** – Includes all persons or entities performing all or part of the services under the contractor has undertaken to perform on the project, regardless of whether that person contracted directly with the contractor and regardless of whether that person has employees. This includes, without limitation, independent contractors, subcontractor, leasing companies, motor carriers, owner-operators, employees of any such entity, or employees of any entity which furnishes persons to provide services on the project. "Services" includes, without limitation, providing, hauling or delivering equipment or materials, or providing labor, transportation, or other service related to a project. "Services" does not include activities unrelated to the project, such as food/beverage vendors, office supply deliveries, and delivery of portable toilets.

- 1.7.2 The Contractor shall provide coverage, based on proper reporting of classification code and payroll amounts and filing any coverage agreements, which meets the statutory requirements of Texas Labor Code, Section 401.011(44) for all employees of the contractor providing services on the project, for the duration of the project.
- 1.7.3 The Contractor must provide a certificate of coverage to the governmental entity prior to being awarded the contract refer<u>to Section 1.6</u> above.
- 1.7.4 If the coverage period shown on the Contractor's current certificate of coverage ends during the duration of the project, the Contractor must, prior to the end of the coverage period, file a new certificate of coverage with the governmental entity showing that coverage has been extended.
- 1.7.5 The Contractor shall obtain from each person providing services on a project, and provide to the governmental entity:
  - 1.7.5.1 A certificate of coverage, prior to that person beginning work on the project, so the governmental entity will have on file certificates of coverage showing coverage for all persons providing services on the project; and
  - 1.7.5.2 No later than seven (7) days after receipt by the Contractor, a new certificate of coverage showing extension of coverage, if the coverage period shown on the current certificate ends during the duration of the project.
- 1.7.6 The Contractor shall retain all required certificates of coverage for the duration of the project and for one (1) year thereafter.
- 1.7.7 The Contractor shall notify the governmental entity in writing by certified mail or personal delivery, within ten (10) days after the contractor knew or should have known, of any change that materially affects the provision of coverage of any person providing services on the project.
  - 1.7.8 The Contractor shall post on each project site a notice, in the text, form and manner prescribed by the Texas Department of Workers' Compensation, informing all persons providing services on the project that they are required to be covered, and stating how a person may verify coverage and report lack of coverage.
  - 1.7.9 The Contractor shall contractually require each person with whom it contracts to provide services on a project to:
    - 1.7.9.1 Provide coverage, based on reporting of classification codes and payroll amounts and filing of any coverage agreements, which meets the statutory requirements of Texas Labor Code, Section 401.011(44) for all its employees' providing services on the project, for the duration of the project.
    - 1.7.9.2 Provide to the Contractor, prior to that person beginning work on the project, a certificate of coverage showing that coverage is being provided for all employees of the person providing services on the project, for the duration of the project.
    - 1.7.9.3 Provide the Contractor, prior to the end of coverage period, a new certificate of coverage showing extension of coverage, if the coverage period shown on the current certificate of coverage ends during the duration of the project.
    - 1.7.9.4 Obtain from each person with whom it contracts, and provide to the Contractor:

- 1.7.9.4.1 A certificate of coverage, prior to the other person beginning work on the project; and
- 1.7.9.4.2 the coverage period, if the coverage period shown on the current certificate of a new certificate of coverage showing extension of coverage, prior to the end of coverage ends during the duration of the project.
- 1.7.9.5 Retain all required certificates of coverage on file for the duration of the project and for one (1) year thereafter.
- 1.7.9.6 Notify the governmental entity in writing by certified mail or personal delivery, within ten (10) days after the person knew or should have known, of any change that materially affects the provision of coverage of any person providing services on the project; and
- 1.7.9.7 Contractually require each person with whom it contracts to perform as required by paragraphs <u>1.7.1. 1.7.7</u>., with the certificates of coverage to be provided to the person for whom they are providing services.
- 1.7.10 By signing this contract or providing or causing to be provided a certificate of coverage, the Contractor is representing to the governmental entity that all employees of the contractor who will provide services of the project will be covered by workers' compensation coverage for the duration of the project, that the coverage will be based on proper reporting of classification codes and payroll amounts, and that all coverage agreements will be filed with the appropriate insurance carrier or, in the case of a self-insured, with the commission's Division of Self-Insurance Regulation. Providing false or misleading information may subject the contractor to administrative penalties, criminal penalties, civil penalties, or other civil actions.
- 1.7.11 The Contractor's failure to comply with any of these provisions is a breach of contract by the Contractor which entitles the governmental entity to declare the contract void if the Contractor does not remedy the breach within ten (10) days after receipt of notice of breach from the governmental entity.

#### 1.8 TERMS AND CONDITIONS.

- 1. Gray County reserves the right to request clarification of information submitted and to request additional information of one or more respondents.
- 2. Any agreement or contract resulting from this RFQ shall be on forms approved by Gray County and shall contain, at minimum, applicable provisions of this document. Gray County reserves the right to reject any agreement that does not conform to this document and any County requirements and contracts.
- 3. The Architect shall not assign any interest in the contract and shall not transfer any interest in the same without prior written consent of the County.
- 4. No reports, information, or data given to or prepared by the Architect under contract shall be made available to any individual or organization by the Architect without the prior written approval of the County.
